Arizona Five Cs SONG CONTEST

The Arizona Five Cs played a large role in the economy of Arizona in the early years. So much so that four of the five Cs are represented on the State Seal. Although they may not play as large a role economically as they once did, the Arizona Farm Bureau Ag in the Classroom (AZFB AITC) Program wants to keep these valuable commodities a part of every Arizonan's vocabulary. And we need your help to do that!

The Contest

The *Arizona Five Cs Song Contest* is open to all 3rd grade classrooms in Arizona. To accommodate curriculum schedules from Districts across the State, we will have both a Fall and a Spring contest.

Fall Contest: Submission due December 1st.

Spring Contest: Submissions due May 1st

Work with your students to create an original Arizona Five Cs song. The song should include the historical importance of the Five Cs and be no longer than 3-minutes in length. Songs can be an audio OR video recording of your students singing your original song. Submissions should include:

- Song (wav, mp3, mp4, pr mov file)
- Lyrics (pdf file)
- Submission Form
- Signed Release Form

Your submission package should be emailed or shared to <u>aitc@azfb.org</u>. Late entries for the Fall Contest will be moved to the Spring Contest.

Prizes

The Top 3 songs for each contest will receive recognition from the Arizona Farm Bureau Ag in the Classroom Program as well as a financial prize to be used to purchase materials for the classroom. The 1st Place song will receive a \$500 Amazon Gift Card. The 2nd place song will receive a \$200 Amazon Gift Card. The 3rd Place song will receive a \$100 Amazon Gift Card.
